CALL TO ORDER

The regularly scheduled meeting of the Benner Township Board of Supervisors was called to order on November 4, 2024 at 7:00 p.m. by the Chairman, Randy Moyer with members Larry Lingle and Kathy Evey present.

Also in attendance were: Sharon Royer, Township Secretary and Rod Beard, Township Solicitor.

A guest list is attached with names of public attendees.

PERSONS TO ADDRESS THE BOARD/PUBLIC COMMENT

- Robert Kuhlman Airports in the Township
 - Mr. Kuhlman noted that he feels that now is the time that the Township consider hiring an Aviation Engineer to review future plans of the airports.
 - Mr. Kuhlman spoke to ask for clarification regarding de-icing protocols and how deicing runoff fluids are controlled or captured.
- 2. Tom Eby Water Update
 - Walnut Grove Estates update:
 - SCBWA completed its feasibility study and they aren't interested in doing the project and has turned it back over to the Benner Township Water Authority to consider.
 - The financing for this project would be through a PENNVEST loan or a grant.
 - There is currently federal money that is available to help with costs relating to PFAS contamination. An authority needs to apply for the grant and there are only 2 authorities involved, Benner Township Water Authority and State College Borough Water Authority.

- The project is estimated at approximately \$400,000 (permitting and engineering) and it was noted that the Benner Water Authority only has 300 customers. It was noted that if all goes according to plan, the money could all be reimbursed. But, if for some reason, it was determined that the project is not eligible for reimbursement, the Benner Authority would be on the hook for the entire project cost, and with a small customer base, it would not be economically feasible to be able to cover \$400,000. It was noted that State College Borough Water Authority is a huge Authority with thousands of customers. What could be a huge financial burden for a small authority would be "just a drop in the bucket" for a huge authority like State College Borough.
- The Feasibility Study is on State College Borough website under "forms".
- The feasibility study estimates that the project would cost 4.8 million
- 3. Dave Palmer Berks Homes / Valentine Road Development
 - Mr. Palmer offered an update on the resolution of the traffic issue for this development.
- 4. Ed Dunkleberger Wedding Venue/Ag Tourism
 - Mr. Dunkleberger owns the Hartle farm across from the Bellefonte Airport entrance and near the Bellefonte Elementary School. He is petitioning the board to allow him to pursue using the farm as a wedding venue and for Ag Tourism (pumpkin patch, parties, weddings, activities, etc).
 - A few residents noted that they would be concerned that this would open the opportunity to start up the controversial hayrides again
 - This petition will be tabled until the December meeting to give the supervisors and Township staff the opportunity to do some research on the zoning issues.

3. Kathy Evey - Re: Bellefonte EMS funds

- Mrs. Evey reported that there is a large cost discrepancy between the costs of services rendered vs the reimbursement costs paid by the Township. The cost of services rendered was \$34,000/year but the Township only gave Bellefonte EMS company \$14,000/year. It was reported that last year the Township gave Bellefonte EMS company an extra \$5,000 which came to a total of \$19,000 for the year. Mrs. Evey proposed that the Township use any leftover ARPA funds to help reimburse the EMS service for their services rendered and give them payment in full. Mrs. Evey noted that the 2025 budget does offer the EMS service an additional \$10,000 for a total of \$24,000 a year, but she feels this is still not enough.
 - A representative from Bellefonte EMS was present to discuss EMS services in Benner Township and surrounding areas.
 - Bellefonte EMS services 10 municipalities total including 3 Boroughs –
 Bellefonte, Milesburg and Unionville

Of these municipalities:

Howard Township, Union Township, Huston Township are all at the requested .5 mill.

Boggs Township is at .43 mill (increase)

Bellefonte Borough increased their reimbursement funds to .3 mill

Benner Township is at .22 mil

Unionville Borough is at .13 mill (increased)

Centre County Government increased their funds this year (properties that are government properties: The Courthouse, the old CentreCrest, Crestside Terrace, Beaver Farms, Governor's Park, Governor's Gate Apartments)

Mr. Lingle asked if offering the EMS service payment in full would help to ensure that
calls placed by Benner Township residents would be answered first. The EMS
service clarified that all calls are answered and responded to chronologically. Mr.
Lingle then asked what is the benefit of offering payment in full if not all participating
municipalities are paying in full. There was a lengthy discussion regarding EMS
services, funding, cost saving procedures and how to make the EMS services more
efficient.
