


Benner Township Board of Supervisors

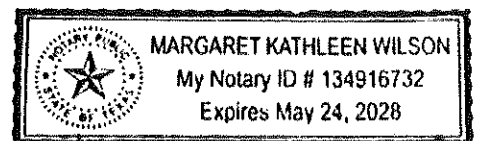
