

Benner Township Planning Commission

July 11, 2024

The regularly scheduled meeting of the Benner Township Planning Commission was called to order at 7:00 p.m. by the Chairman, Willis Houser with members Lee Copper, Randy Moyer, Judson Mantz and Lynn Chaplin present. Members Jim Leigey and Alex Moyer were absent. Also in attendance were Justin Komp, Matt Virgin, Carly Davis and Sharon Royer present.

PERSONS TO ADDRESS THE BOARD

Sun Capp – Bellefonte Warehouse: Matt Virgin, Carly Davis and Justin Komp were present to present the Bellefonte Warehouse land development plan. Mr. Virgin noted that the concept of this land development is similar to what was proposed in past plans but in a much smaller scale. The building will be a warehouse/distribution facility that is planned to be 123,904 sq. ft. in size with 628 parking spaces. Currently it is anticipated that the facility will employ approximately 263 people. The facility will now only be located on Lot 14 in the Benner Commerce Park which is 43.67 acres in size. Access to the lot will utilize Industrial Drive. The previously submitted lot consolidation plan which would have adjoined three lots has been withdrawn. It was noted that additional right of way will be acquired from the Centre County Prison property and turned over to the Township to accommodate a new turning lane on Rishel Hill Road. Mr. Virgin noted that it is hoped to begin construction before the end of the year. Mr. Copper moved to approve the Sun Capp Bellefonte Warehouse land development plan. Ms. Chaplin seconded the motion.

They are requesting that the property be rezoned from Agriculture to R-2. It was noted that this will come before the Planning Commission at a later meeting.

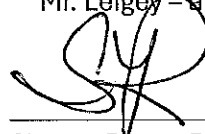
